We will:

- ❖ Care for your child's health, safety and well-being whilst in our care.
- ❖ Provide opportunities for your child to achieve well as a valued member of our school community and God's family.
- ❖ Provide a broad and balanced curriculum in-line with the National Curriculum. The school's Religious Education (RE) programme follows guidance laid out by the London Diocesan Board for Schools
- ❖ Provide a daily act of collective worship.
- ❖ Achieve high standards of work and behaviour through building good relationships and developing a sense of responsibility.
- ❖ Give regular homework in line with the school's homework policy.
- ❖ Keep you well informed about general school matters and about your child's progress in particular.
- ❖ Be open and welcoming at all times.

### Pupils

<b>3.Do listen to people and follow instructions</b>	<i>Don't ignore people or interrupt them</i>
<b>4.Do look after our things</b>	<i>Don't waste or damage things</i>
<b>5.Do be honest</b>	<i>Don't tell lies or cover up the truth</i>
<b>6.Do understand it's OK to make mistakes</b>	<i>Don't laugh at those who are brave enough to have a go</i>
<b>7.Do work hard and try your best</b>	<i>Don't waste time or give up easily</i>

## Parents/Guardians

- ❖ I will support the Christian ethos of the school and encourage my child to do so.
- ❖ I will ensure that my child attends school every day and on time.
- ❖ I will ensure that my child is collected on time.
- ❖ I will not take holidays during term time.
- ❖ I will telephone the school to let them know if my child is sick.
- ❖ I understand that my child may need to receive first aid or urgent medical treatment whilst in the care of school staff.
- ❖ I will ensure that my child wears the school uniform and has a school PE kit available to wear as required.
- ❖ I will ensure my child's book bag is brought to school every day.
- ❖ I will support my child in homework and after-school learning opportunities.
- ❖ I understand that my child will have access to the internet at school.
- ❖ I will monitor my child's use of the internet outside of school, including their use of mobile phones, in order to ensure they are accessing age-appropriate materials.
- ❖ I will monitor my child's use of the internet outside of school, including their use of mobile phones, in order to ensure they are behaving responsibly.
- ❖ I will not discuss school-based issues, school staff, pupils or parents on social media eg WhatsApp, Twitter, Facebook
- ❖ I will make the school aware of any concerns or problems that might affect my child's school work or behaviour.
- ❖ I will support the school's policies (available from the school office) including the behaviour policy and help to promote the Golden Rules.
- ❖ I will conduct myself politely and appropriately whilst on school premises, behaving in a way that sets a good example to the children.
- ❖ I will attend parent meetings and discussions about my child's progress.
- ❖ I will get to know about my child's life at school by reading school newsletters and talking to my child.
- ❖ I will support school events organised by eg. Friends of St George's Hanover Square parent group.
- ❖ I will allow my child to attend school visits.

Department for Education guidance states that written consent from parents/carers is not needed for individual trips/off-site activities that are within school hours as these are part of the curriculum (with the exception of nursery age children). Parents are usually be informed of off-site trips in advance.

Parental consent will be requested for certain trips which are not part of the normal school day e.g. residential trips.
